### 17. General Parish Matters

**17.1**Theft of toddler bucket swings from play area. The insurance claim and implications were discussed and it was agreed that these should be replaced without a claim. Councillor Lipp also passed on some complaints regarding the length of the chains for the other swings at the site and the ways in which this could be achieved safely. It was decided that due to the setup of the swings, there would be a danger of trapped fingers or sharp edges if the current swings were modified and therefore that these swings should also be replaced as complete units including the chains and fittings. **Clerk to action**

#### 19 Any Other Business

Councillor Hignett reported more issues with Duke of Edinburgh expedition groups in the area. The fact that some of the groups seem to be poorly prepared with regards to equipment including maps and that they seem not to be aware of countryside codes as well as concepts such as private property as well as public footpaths are causing concerns and damage within the Parish. It was re-iterated that if the schools' details can be traced, the best way to tackle this is to contact the schools that the groups are from.
